Penning dates and deposits must be received thirty (30) days prior to date of the show. No penning contracts will be accepted prior to September 1<sup>st</sup> of the upcoming penning season. One Hundred percent (100%) of the deposit will be returned if the payback sheets and completed entries are returned to the secretary postmarked within three (3) days of the penning.

The promoter shall be responsible for collection of all day fees. Any fees uncollected will be deducted from the deposit refund.

The promoter shall be responsible for securing the services of 4 judges.

It shall be the promoter's option whether to utilize 24 or 30 head of cattle per set. However, the promoter must use same number of head through out the entire penning.

A board member, director or their alternate must be in attendance at your penning to be counted as a sanctioned penning. Please contact your director.

There must be thirty (30) days between pennings at each arena and also thirty (30) days between pennings held by each promoter.

The Missouri Team Penning Association Board of Directors must approve all pennings.

I understand that all rules of the Missouri Team Penning Association are to be enforced and supersede any "Arena" rules and shall be governed as such.
